1. The customer shall be responsible for all actions and their results resulting from use or utilization of the Software & Data and COTODAMA shall not be responsible for them at all.

2. If the customer receives, in relation to use or utilization of the Software & Date, any inquiry or complaint from a third party (any party inside or outside of Japan regardless of the eligibility as a customer including providers of third-party services.

This applies hereafter) or has any dispute with such third party, he/she shall settle or solve such inquiry, complaint or dispute at his/her responsibility and cost and, upon request from COTODAMA, shall report the progress and results to COTODAMA. 3. The customer shall prepare and maintain computers, other devices, telecommunication lines and other telecommunication environment required for use or utilization of the Software and Data trainform cost and responsibility.

4. The customer shall, corresponding to his/her environment to use or utilize the Software & Data, take security measures such as prevention of computer virus infection, unauthorized access or information divulgement at his/her cost and responsibility.
5. If the customer causes any damage to COTODAMA or a third party by using or utilizing the Software & Data violating any provision under these Terms of Use, he/she shall compensate for such damage at his/her responsibility and cost.
Article 7 (Collecting Information about the Specified Devices by the Software)

1. COTODAMA may store, use or disclose the Information in accordance with the provision under laws for the purposes listed in the subparagraphs below (thereinafter referred to as the Purposes).

(a) To manage the functions of the Specified Device and errors/bugs occurring when the Specified Device is used;

(b) To manage the functions of the Software to provide updated and upgraded versions of the Software;

(c) To develop and improve performance of the products, software and services provided by COTODAMA, COTODAMA's affiliates or a third party (hereinafter generally referred to as "COTODAMA & Others);

(d) To have COTODAMA & Others provide the information related to the products, software and services provided by COTODAMA & Others:

3. COTODAMA may disclose the Information to COTODAMA's affiliates or a third party under the following conditions, (a) COTODAMA may share the Information with COTODAMA's affiliates in order to achieve the Purposes. The term 'COTODAMA's affiliates' means the parent company of COTODAMA and any other corporation for which COTODAMA directly or indirectly holds 50% or more of the voting rights held by all of its shareholders (or, in case the affiliate is not a corporation, any entrepreneur largely influenced by COTODAMA when deciding its business policy);

#### Article 9 (Scope of Responsibility)

1. COTODAMA, COTODAMA's affiliates and the Original Right Holder shall not warrant that the Software & Data are free from any error, bug or other malfunctions, that the Software & Data operates without interruption or that the use or utilization of the Software & Data causes no damage to the customer or a third party. Note that such software or network services may be ceased or suspended in accordance with the judgment by the provider. COTODAMA shall make reasonable efforts to update or improve the information provided by the Software & Data, but COTODAMA shall not provide warranty or representation for correctness, integrity, immediateness, quality or reliability of the information and for no infringement of a third party's corpyright, patent right, trademark right, know-how or any other rights.

8. Use of the Software & Data shall be limited within the country where the customer has purchased the Product (hereinafter referred to as the Purchase Country) and COTODAMA shall not compensate for any damage resulting from the use outside of the Purchase Country.

9. Some functions of the Service and the Software & Data are provided under the license from a third party other than COTODAMA & Others (including but not limited to SyncPower and LyricFind as described in Article 14). Note that, due to change of the license contents with such third party, the functions of the Service or the Software may become unavailable in whole or in part. Article 10 (Responsibility to a Third Party)

If any dispute with a third party results from the customer's use of the Software & Data beyond the scope of these Terms of use on the grounds that the copyright, patent right or other insilectual property right is infringed, the customer shall settle such dispute by himself/herself at his/her cost and keep COTODAMA, COTODAMA's affiliates and the Original Right Holder harmless. Article 11 (Convinit) Protection and Automatic Updation)

1. The customer shall, when using the Software & Data, comply with the Copyright Act, various conventions on the authors' rights and neighboring rights and other laws and regulations related to the intellectual property rights in and out of Japan. 2. The Service shall not warrant that the lyrics are displayed for the musical pieces the customer plays on the Software. Lyrics may not be displayed for some pieces.

3. Utilization of Lyrics shall be limited to personal utilization and non-commercial utilization under these Terms of use. The customer may not reproduce or show the lyrics data, send them to the public, make their sending available, assign or lease them beyond the scooe of private use specified under Article 30 of the Copyright Act.

4. In addition to the provisions to the preceding paragraph, the customer shall agree to the following contents given by LyricFind before utilizing the Software & Data.

"Usage of Lyrics is limited to your personal, noncommercial use in accordance with the terms of this Agreement.

You may not reproduce (other than as authorized for your own personal usage), publish, transmit, distribute, publick idgelay, rent or lend, modify, create derivative works from, sell or participate in the sale of or exploit in any way, in whole or in part, directly or indirectly, any of the Lyrics so provided. You agree that you are not granted any so-called 'karake' or "sing-along' rights to Lyrics and you shall not seek to or remove any vocal track from a sound recording that shall be associated with a Lyric provided to you. You agree not to assign, transfer or transmit any Lyrics to any third party. You agree that you shall not seek to or do anything that will defeat, evado cricicurvent any efforts that may be made to protect the Lyrics form any unauthorized usage. 'Licensee also agrees that except as specifically authorized herein, the foregoing restrictions apply to their use of Lyrics."

Article 14 (Cancellation of the Agreement)

 In case the customer violates any of the provisions under these Terms of Use, COTODAMA may immediately cease the license hereunder and withdraw registration of the customer, or may claim the customer to compensate for the damage it suffers due to such violation.

2. COTODANA or the customer may, by giving a 30days prior notice to the other party in accordance with the method prescribed by COTODANA, respectively withdraw the customer's registration or terminate provision of the Service for any reason whatsever. In this case, these Terms of Use shall be terminated. When these Terms of Use are terminated due to withdrawal of registration, cancellation or termination under this Article, the Service will be unavailable after that.

3. Even in case these Terms of Use are terminated for a reason in the preceding paragraph or for any other reason, provisions under Articles 2, 3, 4, 6, 19, 10, 11, 15, 16, 17, 18 and 19 shall effectively survive the termination.

#### Article 15 (Measures after Cancellation)

When the license under these Terms of Use is terminated or these Terms of Use are terminated in accordance with the provision of the preceding article, the Company shall not be obliged to purchase the Products under the Terms of Use.

The Company shall not be responsible for unavailability of the Product to the customer or restriction over some functions of the Software after such termination.

#### Article 16 (Revision of the Terms)

COTODAMA may revise the conditions under these Terms of Use with giving a prior notice to the customer by sending an e-mail to the e-mail address registered by the customer, giving an announcement on the website specified by COTODAMA or by any other method COTODAMA by ladges appropriate. If the customer does not agree to such revision, he/she shall give a notice to that effect to COTODAMA by the date immediately before the effective date of the revision of the conditions under these Terms of Use and shall immediately stop utilizing the Service. The customer shall agree in advance to such assignment under this paragraph. Article 19 (Others)

Matters not covered by these Terms of Use or any question about construction of these Terms shall be settled through sincere
consultation between the customer and COTODAMA.
